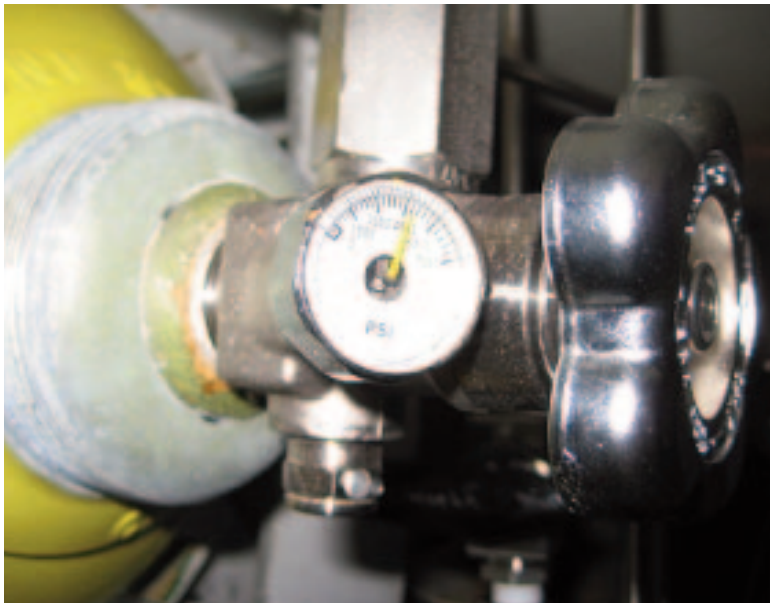

“BOTTLES-OFF” DESIGN ADVANTAGES

- All Chembio shelters have a proprietary valve with integrated gauge
- Bottles remain in the off position until an emergency
- Pressure can be checked without opening the valve
- If a valve leak should occur, only that bottle will be affected
- If a circuit leak should occur, no bottles are affected
- Pre-shift inspections can be conducted at a glance without opening or closing any valves

CONTAINER

- All frames meet MSHA Part 7 structural requirements
- Rebuilt units are outfitted with new doors, handles and seals
- Two sets of protected mine phone connectors are installed
- All frames are pressure tested
- Frame will be painted and new operating instructions, warning labels and reflective tape will be applied

INFLATABLE TENT

- Tents meet MSHA Part 7 structural requirements
- Maximum ambient temperature for all tent models is 66°F
- All tents are equipped with purgeable airlocks and an MSHA-approved strobe with timer
- Two gas sampling ports

SUPPLIES (5-YEAR SHELF LIFE)

- Food bars – 2,000 Calories/Person/Day
- Water – 1 Gallon/Person/Day
- First aid kits
- Chemical toilet with wag bags
- MSHA-approved flashlights
- MSHA-approved strobe light
- Shelter repair kit
- Care pack (Bible, games, writing paper, pens, etc.)

AIR PROCESSING

- Passive CO2 curtains – 5-year life

AIR MONITORING

- All units require Industrial Scientific MX6 gas monitoring kits approved for use in a shelter
- Gas monitors are not included in pricing

TERMS: 50% Down, Balance due Net 20.

WARRANTY TERMS

- AIR/O₂ SYSTEMS – Any warranty work related to the O₂ and Air System will be performed free of charge for the 5-year life of the unit, providing Chembio is contracted to perform the semi-annual inspections.
- STRUCTURAL – The structural integrity of the frame is guaranteed for the 5-year life of the unit, Damage and abuse by the operator is not covered.
- MAINTENANCE COMPONENTS – Items such as timers, strobe lights, thermometers, door hinges, seals, latches, handles, etc. are guaranteed 6 months from the date of shipment.
